APPLICATION FOR DISPLAY FLIGHTS AND AVIATION EVENTS

Requirements for Application

All Aviation Event Applications and supporting documentation shall be submitted directly to the SACAA within the prescribed time frames in order to be processed and considered for an Aviation Operations/Event approval.

This application and any approval obtained from the SACAA, is only applicable to aviation operations specified and approved on the active airside of an aviation event.

It remains the responsibility of the organiser to ensure compliance with all requirements, legislation and approvals required for the hosting of, and safety standards including emergency plans for the public side at such an event.

ALL REQUIRED DOCUMENTS MUST BE CORRECTLY COMPLETED AND SIGNED BY THE APPROPRIATE PERSONS; FAILING THE SACAA MAY BE UNABLE TO APPROVE SUCH AN EVENT.

Definitions

Part 1 Definition:

"general aviation operation" means an aircraft operation other than a commercial air transport, air ambulance or aerial work operation.

"aviation recreation" means flying microlight, glider, balloon, gyroplane, hang-glider, paraglider, model aircraft, light sport aeroplane, touring motor glider, parachute, or involvement in aviation events.

"aerobatic flight" means manoeuvres intentionally performed by the PIC of an aircraft and involving an abrupt change in attitude of the aircraft, an abnormal attitude, or an abnormal variation in speed, not necessary for normal flight;

"aerial work" means an aircraft operation in which an aircraft is used for specialised services as determined by the Director such as-

- (g) aerial advertisement, including banner towing and other towing of objects.
- (i) parachuting;
- (j) aerial recording by photographic or electronic means;
- (l) spraying, seeding, or dusting other than for agricultural purposes and clouds

"special purposes operations" includes—

- (e) advertising;
- (f) aerial recording by photographic or electronic means;
